Following a suggestion of Cllr R Wright for Health and Safety issues Cllr G Carter has volunteered to carry out a recorded monthly inspection of both the Blymhill and Weston under Lizard play areas.

- Cllr M Stokes reported that he had been told there were problems with a style off Beighterton Lane. Cllr D McGowan said he would check this out.

- Cllr D Maddocks said he had received complaints that the grass verges had been cut in October and that a good job was done that there had not been a need for it and they had felt I was a waste of money. Cllr B Cox said that the grass cutting had been taken back in house and this will save the District Council £500,000 over 5 years.
- Cllr D Maddocks said that he had been in touch with the Sign maker from Wheaton Aston and Lapley, with the aim of going around and showing him what signs were needed and to get a quote. This was unanimously backed by all.
