### **MATTERS ARISING FROM THE PREVIOUS MEETING**

### 3087 REPORT OF THE COUNTY COUNCILLOR

Cllr M Sutton reported:

- That following the Chancellors doubling of the Household Support Fund from £500m to £1 billion to help vulnerable households in the UK, Staffordshire County Council will know more about how it will give Council Tax assistance and help with fuel bills. The Council has already distributed £16 million.
- That for the coming tax year Community groups can again apply to get funding.- Cllr N Parton said that the Village shop needed some new shelving and signage. Cllr M Sutton responded that he would pass on the criteria to him.

## 3088 REPORT OF THE DISTRICT COUNTY COUNCILLORS

Cllr B Cox reported that:

- The Council Tax in South Staffordshire District Council was one of the loest in the country for the District Council would equate to £5.00.
- South Staffordshire District Council won the title of UK Council of the Year at a national awards ceremony by public sector awards body iESE, after its judging panel received more than 260 nominations from 81 different public sector organisations from the UK and

overseas. The district council also won two Gold Awards the Asset Management and Regeneration Award category for its Community Hub project, and the Working Together Award category for its Localities+ model. This was due to the Council having good staff.

#### 3089 PLAY AREAS

Cllr N Parton reported:

- Following the ROSPA annual audit of the Play Areas, actions to be undertaken at the Weston under Lizard Play Area and the Blymhill Play Area all items have been other than the installation of 2 new swing seats.
- Cllr N Parton also said that the Education Boards for the play areas to help children learn from play had been ordered. – Cllr D Maddocks thanked Cllr N Parton for the work carried out.
- Cllr V Cook asked if there was any news on the work that needs to be carried out on the Path. Cllr N Parton said that he was trying to contact the new person at Bradford Estates to find out what action was to be taken.

#### 3090 FOOTPATHS AND HIGHWAYS

- It was also raised previously there was a lot of leaves and debris on the path between Rectory Drive and the Play area, this had been cleared by South Staffordshire District Councils Street Scene.
- Cllr D Maddocks reported that A person has started clearing on of the Public Footpaths across Blymhill for the Princes Trust award.
- Cllr D Maddocks reported that the County Councils Road Master had been around Great
  Chatwell and had done a good job. Cllr M Sutton said that they had 2 of the machines but
  when it was wet they could not be used and when forecast to be icy those were the same
  staff that did the gritting so that took precedence.
- Cllr D Maddocks also reported that the Weston under Lizard Action Group had been asked
  if they would organize some Volunteers for a speed watch group for which the Parish
  Council would pay for training and equipment costs but had been told they were unable to
  do so.
