- Cllr B Cox said he must apologise because at the last meeting he said that there would be
 no charge for the Green Bin Collection by the South Staffordshire District Council and that
 was actually incorrect as the cost was to remain the same as last year.
- Camp Bestival held a Public Meeting on the 17th May, Clr A Lowe reported that there would be far fewer attendees with majority of tickets being weekend tickets and once in that was it, with just 2,000 day tickets each day. The Music stage was to be much further into the park so should be better. The same Liaison man was involve - Mark Blackstock and the same firm that did the Traffic Management for the V Festival was also being used. Cllr V Cook said that at the meeting there were many unhappy people from various areas and Parish Councils there, regarding both how there was little notification regarding the Licensing and what that included. It was suggested that Licensing applications should automatically be sent out to Parish Councils in the same way that Planning Applications are sent out. It was noted that Music was allowed to Midnight - later than V Festival. This raised concerns both at the Public Meeting and the Parish Council that seemed odd considering this Festival was aimed at Family's with young children. Cllr V Cook also said that Mill Lane was to be closed during the festival. It was stated by the organizers, when asked if anything was being done for the residents and the local area, as was done by the V Festival, that there were no free tickets or discounts, but some local charities would be given funds, how much and to whom they would not say.
