3130 MINUTES OF PREVIOUS MEETINGS

RESOLVED: That the minutes of the Parish Council meeting held on Wednesday 23.11.2022 be approved as a correct Record and governance of the Parish Council.

The Parish Clerk reported that the issue with the Stiles near Blymhill Church said that the Rights of Way team were going to discuss with the Land owner to offer to replace the styles with new ones.

3133 REPORT OF The COUNTY COUNCILLOR

- Cllr M Sutton reported that the County Council Council Tax, would increase by 2.9% and 2% for Social Care, this he said was a lot better than many County Councils
- He was also pleased that the Path on the A5.

Cllr D McCowan asked why at the start of the period when snow fell, there was a lack of gritting. Cllr M Sutton responded that there had actually been more grit used in this period than most years he said that he would send a link for the Gritting Routes.

Cllr N Parton raised the issue of the ditch that had been filled as the Council had put the mud and debris from clearing the road rather than clearing it - the response from Mark Keeling Highways Liaison was read out - "In regards to the verge areas, following the clearance works, the spoil was put back on the verge, most of the lane is high banked and therefore the spoil was put at the lower

This is common practise as the spoil would be classed as contaminated waste and therefore both difficult and expensive to remove from site. I understand we cleared the drainage ditches and no further works are planned at this time." Cllr M Sutton said he would look into this.

Cllr D Maddocks raised the question why had Mark Keeling said that "We have checked our records and Breighterton Lane is on an annual inspection route and was last inspected during October at which time there were no actional defects, therefore it is likely the potholes you mention have appeared after the inspection took place. Currently we have only one enquiry raised for Breighterton Lane which relates to a pothole near to the A5 so it looks like these particular potholes have not been reported to us." Cllr M Sutton said that that was not correct as he knows the state of that part of Beighterton lane and it was bad before October and he would get in touch with Mark Keeling on this matter. Cllr L Cross also added that a number of the taxis that picked up school children were threatening use it so it could impact school children.

3135 PLAY AREAS

- Following the annual ROSPA audit Cllr N Parton reported that in the Weston under Lizard play
 area, the Tyre Swing does not now meet the required standards and would need to be
 replaced but following investigation a replacement would cost close to £4,000 so best to just
 remove it at this stage- this was agreed to by the Parish Council.
- Cllr N Parton then reported that the Picnic table that needed to be replaced would cost £250 (this had been agreed at the last meeting.

3136 FOOTPATHS AND HIGHWAYS

- It was stated that the Community Payback scheme had done a good job on both Footpaths
 that run parallel to the A% that goes from the old School in Weston under Lizard to Weston
 Bank, as well as from the A5 along Beighterton Lane and Rectory Drive.
- At Weston Bank it was reported that there was a blocked Drain
- The path in Blymhill to Grove Farm has been cleared and Cllr L Cross was going to take photo's to check the integratory of the path
